The CleanAir Pro PAPR systems are a new generation of powered air purifying respirator combining a waist-mounted CleanAir 2F blower unit with the option of 2 different head piece configurations, providing user-selectable air flow rates and an ability to excel in dusty environments where surface finishing and grinding are your main focus.

CleanAir Pro PAPRs will run for 10 hours on a single charge and are equipped with a variable flow-rate motors that can be set to draw up up to 235 liters of air a minute through the included headpiece. Systems ship with P3 filters (HE2 equivalent) are suitable for use against a wide range of organic solid particles and aqueous mists, including silica dust, smoke, fibers, water-based chemica vaporsl, bacteria, and viruses at 99.95% efficiency. Chemical combination filters are available as an add on listed under filters and spares.

The CleanAir Pro blower unit meets IP65 standards for ingress protection and features a unique automatic closing system that prevents unwanted contamination of the unit by particles while the filters are being changed, making it ideal for heavy duty applications. The integrated full color display clearly shows all the relevant information needed and is easily operated with gloved hands.
